- Household income, minimum 2.5 x the annual rent:
 $\text{£1000pcm rent} \times 12 \times 2.5 = \text{£30,000pa pre tax income (Guaranteed Income only)}$
 $\text{£2000pcm rent} \times 12 \times 2.5 = \text{£60,000pa pre tax income (Guaranteed Income only)}$
- Minimum 6 month resident in the UK
- No County Court Judgements (CCJ) or Bankruptcy
- Utility account in your name at your current home (Gas, Electric, Water and or Council Tax) or UK Photo Driving Licence / Most recent bank statement
- Have available forms of photo Identification
(Passport or UK Driving Licence, Residence Visa)
